New Business:

When he spoke with Linda, he sated he was trying to get our attention regarding people continuing to go down Northbrook Road after County AB to the east. On the Village side which is the southside of the road is a "No Outlet" sign. He wants a sign on the northside of the road that is lite and flashing for "Dead End". A "Dead End" sign has been put in but it will not be lite and we also replaced the Village sign to "Dead End".

Adopt the Town Budget 2025 Sec. 65 (90)(3)(b) which includes General Fund Expenditures and General Fund Revenues: Ken moved with a second by Leonard to approve. Motion carried. 2 ayes, 0 nays

A letter will be sent to Janet Zehren regarding end caps not being put on replaced culvert. If not done by 12/31/24, the County Highway Department will do it at her expense.
