Treasurer Jerry Zellner stated that as of November 30, 2024 the town has a checking balance of \$137,867.31, ARPA is \$45,244.38, and the CD of \$192,462.17 for a total of \$375,573.76.

Zoning Administrator Edith Lauscher was excused but we received money for building permits: Karl Kickbush -\$175, Ryan Rohr- \$75 and Josh Haen - \$75.

New Business:

Reviewed the town fees and no adjustments at this time.

The annual fire and rescue bill is: Fire - \$44,583.92 and Rescue - \$46,155.74.

Since the town no longer needs to pay for an ambulance with the ARPA funds, this money will be moved to the road improvement project already submitted along with any leftover money from the B/K line culvert project.

Winter roads are set to be done in this order: Luxemburg, Church and then Valley.

Next monthly meeting is Wednesday, January 15th.

Linda was approached by Com2 Recycling Solutions Electronic Recycling. We will look into it further.

Dr. Jo Ellen Fairbanks, District Administrator, will come in March to update us on the school activities in the district.
